Erin Kightlinger made a motion to approve the meeting agenda. Meg Henry seconded the motion. Approved.

Discussion over State Team Apparel and discussion to offer regional apparel store.

Helen Nabors made a motion that all Alabama clubs that have a gymnast qualify for the Regional State Team (Level 6-8, Xcel Gold, Platinum, and Diamond) will be given 2 shirts per level with a max of 4 per gym. There will be an opportunity to purchase additional Alabama apparel for anyone that wishes to purchase it.

Meg Henry updated the Committee on Optional Training Camp. The OTC is now full, and will take place in Auburn, Alabama, on Friday, July 21 from 9:00-4:30.

State Meet bids for 2024 Compulsory State, and 2025 Optional/ Xcel State, are open from July 15- November 15, 2023. Bids will be discussed and voted on in the November SAC Meeting.

Change in Fees:

J.R. Zeringue made a motion to increase State Meet fees, Compulsory, Level 6, and Xcel will be 108.00. Optional 7-10, will be 118.00. This increase will begin at 2023 Compulsory State, and 2024 Optional/ Xcel State Meet.

Sandi McGee made a motion to increase Alabama State Registration Fees from 15.00 to 18.00 per gymnast effective September 1, 2023, for Compulsory gymnasts and January 1, 2024 for Optional and Xcel gymnasts.
